

**AN ORDINANCE OF THE CITY OF STAFFORD, TEXAS, CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION FOR CITY COUNCIL HELD ON MAY 3, 2025, FOR CITY COUNCIL POSITION NUMBERS 3 AND 4.**

WHEREAS, a General Election was held in the City of Stafford, Texas, on May 3, 2025, for the purpose of electing Councilmembers for Positions 3 and 4; and

WHEREAS, said General Election was duly and legally held in conformity with the election laws of the State of Texas, and the results of said Election have been verified and returned by the proper judges and clerks; and

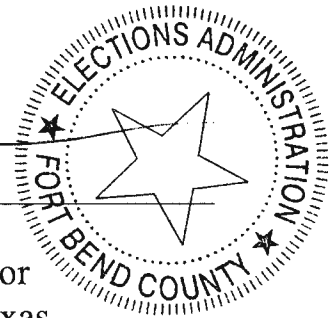
## CANVASS
