MINUTES REGULAR CITY COUNCIL MEETING CITY OF STAFFORD, TEXAS WEDNESDAY, JANUARY 15, 2025

On the 15th day of January, 2025, at 6:30 p.m., the City Council of Stafford, Texas met in regular session in the Council Chambers. Mayor Mathew called the meeting to order. The following members of the City Council were present: Mayor Ken Mathew, Mayor Pro Tem Alice Chen, and Council Members William K. Bostic Jr., Tim Wood, Christopher Caldwell, Virginia Rosas, and Xavier Herrera. Absent: None. The following City Staff were present: City Secretary Roxanne Benitez, Chief of Police Richard Ramirez, Director of Recreation Susan Ricks, Police Captain Nathan Cohn, Director of Public Works/Development Services Kyle Jung, Code Compliance Administrator Scott McElrath, City Planner Thomas Coon, Senior Development Services Specialist Laura Morales, Police Captain Joe Williams, Fire Chief Larry Di Camillo, Assistant Chief of Police Kelly Wright, Fire Marshal Jon Lopez, and City Attorney Bridgette Begle (left at 8:26 p.m.).

1. Call to Order.

Mayor Mathew called the meeting to order at 6:30 p.m.

2. Pledges of Allegiance.

Mayor Pro Tem Chen led the pledge to the United States flag. Council Member Herrera led the pledge to the Texas flag.

At this time, Council Member Herrera made a motion to take Agenda Item 8 after Agenda Item 5, and Council Member Wood seconded the motion. Mayor Mathew, Mayor Pro Tem Chen, and Council Members Bostic, Wood, Caldwell, Rosas, and Herrera voted "Aye". "Nay" – None. Motion carried 7-0.

3. Public Comments.

Public Comments were received from the following:

• Clay Foster, who lives at 10500 Fountain Lake Drive, wished everyone a Happy New Year. He spoke on City finances, law enforcement, and a lack of safety equipment.

Council Member Wood made a motion to allow Mr. Foster to speak for an additional minute, and Council Member Herrera seconded the motion. Mayor Mathew, Mayor Pro Tem Chen, and Council Members Bostic, Wood, Caldwell, Rosas, and Herrera voted "Aye". "Nay" – None. Motion carried 7-0.

• Mr. Foster spoke on confronting uncomfortable truths and City Council having the best intentions for the City.

4. (a) Discussion regarding a proposed replat of a tract or parcel containing 1.065 acres or 46,394 square feet of land being situated in the Jane Dees Survey, Abstract no. 404, Harris County, Texas being all Restricted Reserve "A", Block 1, Hamor Subdivision.

City Planner Thomas Coon provided a PowerPoint presentation on the proposed replat.

Mr. Coon answered questions from the Council Members.

5. (a) Discussion regarding a proposed replat Unrestricted Reserve "B-2-A" of Replat of Failla Division, a Subdivision in Fort Bend County, Texas according to the map or plat thereof recorded in Slide 2322/A of the Plat Records of Fort Bend County Texas.

City Planner Thomas Coon provided a PowerPoint presentation on the proposed replat.

Mr. Coon answered questions from the Council Members.

The owner, Chen Wang, spoke on the proposed replat.

8. (a) Discussion regarding special purpose districts, including, but not limited to emergency service districts, security districts, and tax increment reinvestment zones.

Council Member Herrera advised that he requested this item be added to the agenda. He spoke regarding various special purpose districts.

Council Members and City Staff discussed various special purpose districts as well as their concerns. City Attorney Bridgette Begle answered questions from Council Members. Council Member Herrera also answered questions from the other Council Members.

Director of Public Works/Development Kyle Jung spoke on the current permitting software, previous permitting software, and the proposed permitting software.

Council Member Herrera exited the meeting at 7:53 p.m.

Senior Development Services Specialist Laura Morales spoke on the need for a new permitting software.

Ms. Morales and Mr. Jung answered questions from the Council Members.

Code Compliance Administrator Scott McElrath provided some history on the previous and current permitting software systems.

Council Member Herrera entered the meeting at 8:06 p.m.

Mr. Jung continued to answer questions from the Council Members.
