## MINUTES STAFFORD CENTRE COMMITTEE MEETING MONDAY, JUNE 10, 2024

On the 10<sup>th</sup> day of June, 2024 at 12:00 p.m., the Stafford Centre Committee of Stafford, Texas met in regular session at the Stafford Centre in said City. The following members of the Committee were present: Committee Members Virginia Rosas, Alice Chen, and Xavier Herrera. Absent: None. The following City Staff were present: FMSquared President Bryan Blaum, Assistant General Manager Rebecca Hathorn, Director of Recreation Susan Ricks, Administrative Assistant of Recreation Stefanie Plata, and Assistant City Secretary Shandra Phillips.

- 1. Call meeting to order.

  Committee Member Rosas called the meeting to order at 12:05 p.m.
- 2. Approval of minutes for Stafford Centre Committee Meeting held on April 22, 2024.

Committee Member Chen made a motion to approve the minutes for the Stafford Centre Committee meeting held on April 22, 2024, and Committee Member Herera seconded the motion. Committee Members Rosas, Chen, and Herrera voted "Aye"; "Nay" – none. Motion carried 3-0.

3. Discussion and Consideration regarding the Election of a Chairperson for the Committee.

Committee Member Rosas made a motion to appoint Committee Member Herrera as Chairperson, and Committee Member Chen seconded. Committee Members Chen, Rosas, and Herrera voted "Aye"; "Nay" – none. Motion carried 3-0.
